- ST. JOSEPH'S NEW PROPERTY PROJECT continues making progress. At the informational meeting on Jan. 23 there were parishioners, project planning committee, pastoral council and finance council members present. Also attending were visitors from the Austin Diocese representing the Facilities and New Construction Department. They outlined the process steps of developing a building project and offered guidance. Currently the newly purchased property is in the process of being cleared of three old houses, removing unwanted brush, trees and junk. Two of the old houses are for sale (to be moved by buyer) and one has been demolished and hauled off. Next steps are to investigate the disposition of the alley that divides the property, any utilities and easements and apply for real estate tax exemption.
