The Austin Diocese gets a new Bishop who is one of our locals from Cameron, TX. In May 2025, the Catholic Church got a new Pope, Leo XIV, who is the first American Pope.

On Wednesday July 2, 2025, our Holy Father, Pope Leo XIV, named the Most Reverend Daniel E. Garcia the 6th Bishop of the Diocese of Austin. The installation of Most Rev. Daniel E. Garcia as the sixth Bishop of Austin will take place on Sept. 18, 2025.

Bishop Garcia was born on August 30, 1960, and grew up in Waco and Cameron, Texas. He is bilingual in English and Spanish and has three younger sisters. He has served in many parishes - St. Catherine of Siena, Cristo Rey Parish, St. Louis King of France Parish, St. Vincent de Paul Parish all in Austin also at St. Mary Magdalene Parish in Humble, Texas. for the Galveston-Houston Archdiocese.

From the July Council Meeting: GK Kenny Syrcek and members enjoyed a delicious meal of cubed rib eye steak, gravy, mashed potatoes, green beans, by Lecturer Dwayne David, Marty Elman and Rodney Barcak. For dessert: dark chocolate rice crispy squares and chocolate chip pan cookies by Debbie Konarik. GK Kenny reviewed the calendar for the remainder of July including the semi-annual audit on July 15th, the Rockdale Food Pantry delivery on the 18th. The Council voted to donate \$500 to the Rockdale homecoming Assn. but the actual donated amount was \$150, and the council voted to contribute \$500 to the Texas State Council for flood disaster relief in the Texas hill country. The June Council meeting had concluded with reelection of all current officers for 2025-2026 by acclimation. Two of the three trustees agreed to advance by one year and outgoing 1-year trustee, Nick Guzman agreed to the 3-year position (as shown in the officers list above).

- KC BBQ HOUSE PLANS instead of the original idea of sidewalks between the BBQ House and storage building, further discussion led to the idea of a rectangular concrete slab to be poured between the two buildings after the storage building was repositioned closer to the BBQ House. The (portable) storage building was slid to the south to be aligned with the BBQ House during the first week of June. The concrete slab was to be formed and poured by a contractor on July 11, completing the planned improvements to the BBO House.
