Fr. Michael, founder of our order (1852-1890), Fr. Patrick, (1867-1928), and Fr. **John**, (1870 – 1939). Their father, Patrick McGivney, Sr. and wife Mary, were Irish immigrants settled in Waterbury, CT. Patrick, Sr, was a hardworking molder in a local brass mill. They had a large family of thirteen children nearly half of them died very young as did their dad. This left the family in dire straits, like many in their parish and city. This prompted Michael, age 20, to leave the seminary to care for the family. He saw the needs of the families, especially those who lost their breadwinner, to disability or death and this eventually led to the founding of the Knights of Columbus. 
